**OCTOBER 1, 2022**

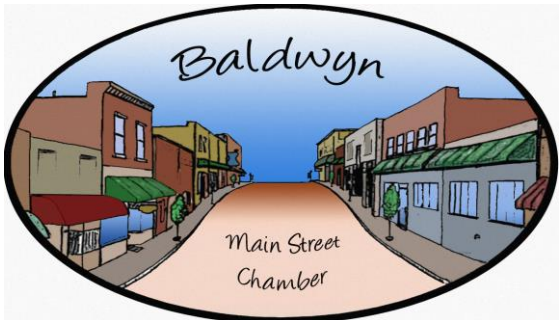
Baldwyn Main Street Chamber is excited to bring back our annual Okeelala Festival and Car Show! It will be Saturday, October 1, 2022 at Latimer Park, Baldwin, MS. Electricity is available for vendors upon request and payment (although a heavy-duty extension cord may be needed). Vendor parking is NOT allowed behind the booths, but is available in parking lots at each end of the park. Fees for a booth are \$50 without electricity, \$75 with electricity, and \$100 for ALL FOOD vendors the application should be returned by September 9<sup>th</sup> for these rates. Applications received after September 9<sup>th</sup> will be charged an additional \$10 Late Fee.

Vendors may set up tents and goods, etc., the night prior the festival at their own risk. Security will be set up Friday night (7pm—7am) to oversee festival area. You MUST notify our office if you intend to set up on Friday evening.

Volunteers will be on site to assist you during set up. All food vendors are required to pay 9% sales tax on hot prepared food. All sales tax should be turned in at the end of day to the BMSC information tent.
